In continuation of Government Order No. 06-JK(ST) of 2024 dated 20.02.2024 and Government Order No. 10-JK(ST) of 2024 dated 05.03.2024 and on the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the appointment of Shri Vijay Kumar S/o Dhian Chand R/o Badheri Samba as Driver-II under SC category in the Jammu & Kashmir Energy Development Agency (JAKEDA), Science and Technology Department in the Pay Level 2(Rs 19900-63200) notionally w.e.f. 20.02.2024 and monetarily with immediate effect.

The appointee shall report to the Chief Executive Officer, Jammu & Kashmir Energy Development Agency within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego his right to appointment and the shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- Academic/ Technical Qualification Certificates. i.
- Matriculation/Date of Birth Certificate. ii.
- Health Certificate from the concerned Chief Medical Officer of the iii. District.
- Domicile Certificate issued by the Competent Authority. iv.
- Valid relevant Category Certificate.

The appointment of the above candidate shall further be subject to the following conditions:

- The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of a. Birth/Reserved Category Certificate(s) from the concerned issuing authorities is found fake/forged, his appointment as Driver II in the Jammu & Kashmir Energy Development Agency (JAKEDA) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- That if the candidate has taken loan for self employment from b. DIC/Employment Department, to be ascertained from the District

Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- The salary of the appointee shall not be drawn and disbursed to C. him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate(s) are received from the concerned Authorities/Agency.
- The appointee shall be on probation for a period of two years. d.
- The appointment of the candidate shall be governed by the "New e. Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- The inter-se-seniority of the appointee in the Jammu & Kashmir f. Energy Development Agency (JAKEDA) shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- The appointment of the above appointee shall be subject to outcome g. of writ petition(s), if any, pending before Competent Court of law.
